Sub: Amendment in ESI(Central) Rules, 1950 relating to Maternity Benefits under ESI Scheme.

Sir/Madam,

With reference to above mentioned subject, it is to inform you that the amendments vide gazette notification dated 20<sup>th</sup> January, 2017 in Rule 2, Clause (6) and Rule 56 Sub Rule (2) Employees' State Insurance(Central) Rules, 1950, followed by instructions issued by Benefit Branch on 6<sup>th</sup> February, 2017 and 18<sup>th</sup> July, 2017 will be deployed in module in 2 phases. In the first phase which has been deployed today the following changes have been made in module:

1. For confinement or expected date of confinement w.e.f. 20<sup>th</sup> January, 2017 Maternity Benefit will be processed for 26 weeks of which not more than eight weeks shall be prior to the date or expected date of confinement for 2 surviving children. For I.W having 2 or more than 2 surviving children, maternity benefit will be processed for 12 weeks of which not more than six weeks shall be prior to the date or expected date of confinement.
2. The system has details of family w.e.f. mid 2010 only and therefore will display details from such time only.
3. In the existing module an I.W could claim Maternity Benefit without entering the details of the child in family. Also family details can be changed from employer login also. Now onwards the name of any child for whom Maternity Benefit is claimed, will be automatically entered in family details. Also details of changes made in children of I.W will be visible to both Claim Clerk and Branch Office Manager.

4. The self declaration as per letter No. R/14/13/99-Bft. II dated 18.07,2017 taken from I.W in any form may be retained for records. The module does not have any feature for retention for same. The same applies to verification report to be conducted as per the same letter.
5. To take care of any changes which are made subsequent to availing maternity benefit by I.W., a report in the following format will be available on Monthly and Yearly basis in BMs login:

6. For cases which are otherwise entitled for 26 weeks Maternity Benefit but for which 12 weeks Maternity Benefit Payment has been made, the cases may be reopened by raising tickets with IT Helpdesk. Payments of balance amount are to be made online only.
7. Adoption and surrogacy maternity benefit will be deployed in next phase.
