**Corrigendum to Tender for providing Security Services in ESIC Offices in M.P. Region.**

1. The words "an Account Payee Demand Draft/Pay Order/ Bankers Cheque" given on page six column no.17(e) third line may now be read as "a bank Guarantee or Fixed Deposit".
2. Column no. 4 & 5 in Annexure-V i.e. Price Bid, are now deleted.
3. A note at the bottom of the table in Annexure-V is added as follows :-

"Gratuity, Bonus and Paid leave will be reimbursed on actual basis upon submission of the bill complete in all respects for the period covered by this contract"

- b) The Regional Director, Regional Office, ESI Corporation, Nanda Nagar, Indore may terminate the contract if it is found that the contractor is black listed during last 5 years by any of the Govt. Departments/Institutions/Autonomous bodies/Local Bodies/ Municipalities/Public Sector Undertakings etc.
- c) The Regional Director, Regional Office, ESI Corporation, Nanda Nagar, Indore may terminate the contract in the event the successful bidder fails to furnish the Security Deposit/ Performance Security or fails to execute the agreement within the specified period.
- d) The Regional Director, Regional Office, ESI Corporation, Nanda Nagar, Indore has right to reject the bid if tender received is found deficient on account of registrations, documents or required information.
- e) Tender containing false misleading information will be rejected and may also be liable for consequences for submitting false information.

**17. Award of Contract :-**

- a) The Regional Director, Regional Office, ESI Corporation, Nanda Nagar, Indore, will award the contract to the successful evaluated bidder whose bid has been found to be responsive and who is eligible and qualified to perform the contract satisfactorily as per the terms and conditions incorporated in the bidding document.
- b) Evaluation of Financial Bid will be made on the basis of quoted Service Charges only as other components like the wages are fixed as per the minimum wages notified by the central govt along with other fixed statutory liabilities like the service tax, ESI, EPF etc.
- c) In case more than one price bid quoting the same rates are received, the award of the contract will be decided on the basis of higher experience in providing security services. If the experience is also equal, then the basis for selection would be the higher turnover in the f.y.2014-15. The decision of the Regional Director will be final in this regard.
- d) The successful bidder will be required to execute an agreement within a period of 2 weeks from the date of issue of Letter of Award unless extended by the Regional Director, Regional Office, ESI Corporation, Nanda Nagar, Indore. up to a maximum of another two weeks on a written request from the bidder.
- e) The successful bidder shall be required to furnish a Performance Security in the form of Security Deposit within 15 days of receipt of "Letter of Award" for 5% of the awarded value in the form of a Bank guarantee or Fixed Deposit issued from any Nationalized Bank, in favour of "ESI Fund Account No. 1" payable at Indore. The Performance Security/ Security Deposit shall be returned within two months after the expiry of contract and completion of all contractual obligations. In case the contract period is extended further, the validity of Performance Security shall stand automatically extended.
